In many applications there is a need to have the lowest possible flow rate. For long the lowest flow rate has been 0,4 L/min. In the effort to help the customers to optimize their flow rate and save water, Bertfelt Teknik has now added 5 new flow rates below 0,4 L/min: 0,15 L/min, 0,2 L/min, 0,25 L/min, 0,3 L/min as well as 0,35 L/min. All with the standard accuracy of nominal flow rate +/- 10% over the whole pressure drop range 1,4-10 Bar.



Obtention of potable water certificate: ACS

Bertfelt Teknik AB has obtained a new certificate for its constant flow valve range: ACS, Attestation de Conformité Sanitaire. The "Attestation de Conformité Sanitaire" (ACS) is the French potable water certification which demonstrates the suitability of products that will come into contact with water intended for human consumption.

Thanks to this approval, Bertfelt Teknik can supply its high-quality constant flow valves, System Maric for applications requiring potable water certificate, not only in France but also in other European countries through the principle of mutual recognition that stems from Regulation (EC) No 764/2008.

Mutual recognition ensures market access for products that are not subject to EU harmonisation. It guarantees that any product lawfully sold in one EU country can be sold in another. This is possible even if the product does not fully comply with the technical rules of the other country.
